This Addendum supplements or modifies the original Solicitation noted above and is made part of the Invitation for Bid and resulting contract documents. The following modifications are included as part of this Addendum:

See attached for revised drawing M1 with required pipe supports identified.

Note the following Question(s) and Answer(s) below:

1. Is a geotechnical report on the proposed site available?

Response: Once the clearing and grubbing is completed onsite to the subgrade elevation, a geotechnical engineer will access the site and test for bearing capacity.

2. How long does the contractor need to hold their bid?

Response: The Contractor shall hold their bid for 90 days.

3. Regarding drawing C2, please confirm whether the hydrant and valve shown near the southeast corner of the LOD is part of this contract.

Response: The hydrant, valves, 8"x 8" tees and suction/discharge isolation valves adjacent to Old Stage Road Highway will be installed by the water main contractor as part of a separate contract.

4. Is there any need or requirement to raise the overhead power lines near the proposed entrance to the site?

Response: There is no need/requirement to raise the overhead power lines near the proposed site entrance.

5. The tanks specified in Section 11340 appear to be "traditional" chemical storage tanks (primary with secondary containment tank, lifting lugs, tie-down lugs, bulkhead fittings / connections, ultrasonic leak detection with 4-20 mA signal, 24" vented manway, etc.). The tanks shown on drawing D1 appear to be 55 gallon drums on containment pallets. Please clarify what is required.

Response: The tanks required are 55-gallon drums on containment pallets, as shown on drawing D1.

6. Is the contractor required to provide the initial fill-up of sodium hypochlorite?

Response: Yes, the Contractor is required to provide the initial fill-up of sodium hypochlorite.

7. Section 16612 (Emergency Generator System) specifies a diesel-engine generator. Drawings E1-E5 show a natural gas generator. Please clarify.

Response: The generator shall be a natural gas generator as shown on Drawings E1-E5.

8. Should we want to go look at the proposed site, is there someone that we need to contact to arrange a visit?

Response: No prior meeting or site visit has been held for the project. The existing pump station site is wooded
