Question: Will you please verify that you want only one hard copy of each proposal?

Yes

Question: On page 7 of the two RFPs, it states "The complete RFP with appropriate signatures

and information, including acknowledgement of any applicable addendum." Does Isle of Wight

want us to include all 35 pages of the RFP as well as the attachments at the end of the RFPs and

put this information in its own tab?

Question: On page 9 of the two RFPs, it states "The prime consultants are encouraged to achieve

all, or a percentage of the required DBE participation/goads determined for this project by the utilization of BOWD approved firms." Are BOWD approved firms listed under the Virginia Department of Small Business and Supplier Diversity or is there a separate list of approved firms?

If so, where can we find that as we were not able to find a listing on the BOWD website.

Yes, they are listed under the Virginia Department of Small Business and Supplier Diversity website-<u>www.sbsd.virginia.gov</u>.

<u>Question</u>: Of the list of Required Federal Forms listed on page 35 of 35 of the RFP, it appears we do not need to complete Vendor Payment Compliance Report, Form C-63, as it appears it is an example of what we would complete once awarded the project. Will the County please confirm that this form is not required at this stage.

No, this form is not required at this stage. It will be required with contract invoicing after award.

Question: If we have DBE firms on our team to meet the DBE percentage of participation, do

we still need to complete Form C-49?

The C-49 is only required in cases where the proposal does not document meeting the DBE goal sufficiently.

Question: In both RFPS, there are "optional services" listed that may or may not happen for the

project. If we have identified a DBE sub for one of those optional services, we do not calculate

them into the DBE participation requirement? Also, would they be excluded from submitting a

letter of commitment and signing the Certification of Binding Agreement form (Form C-112)?

Further clarification on how we address this would be appreciated.

Yes, Optional Services subconsultants can be included in your calculation by submitting a letter of commitment and signing the C-112. However, if at the County's discretion those services are NOT contracted after award, the prime is STILL responsible to meet the DBE goal as stated in the RFP. Good Faith Effort Criteria may only be applied to non-optional contract items.

<u>Question</u>: In RFP #23-4510-169(Main Street/route 258 at Route 10 Bypass) is the County's expectation that the 10-month project schedule listed in the RFP is from NTP to advertisement for construction or is the expectation that 18 months will account for the duration from NTP to right -of-way approval/right-of-way acquisition?

The tentative schedule is 18 months from NTP to RW phase, and an additional 18 months from RW phase to construction advertisement. The final schedule will be set during PE when VDOT Scoping is closed.
