### **Route 10 Watermain Extension Phase II**

SCOPE OF WORK: The project is generally described as extending and 8" and 12" water main approximately 1.34 miles to connect the existing water supply from the Town of Smithfield to Hardy Elementary School. The contractor shall provide all labor, superintendence, material, tools, equipment, and other ancillary items necessary to complete this project. This project is the second of two phases that are required to provide water to a new County elevated water storage tank currently under construction at Hardy Elementary School. The Phase I project will bring water from the Town's system on the south side of the Pagan River to Berry Hill Road, and Phase II consists of the waterline from Berry Hill Road to Hardy ES. Water from the Phase I project may not be available for flushing prior to the commencement of the Phase II work. An overall exhibit is provided as File Attachment "Detail Plan and Profiles".

#### WORK DAY

Daily work may begin at 8:00 AM with work areas secured by 5:00 PM unless otherwise requested and approved by the County in writing. Based on our understanding of VDOT's time and day restriction, daily work along Route 10 Business may be limited to the hours of 9:00 AM to 3:00 PM, Monday through Friday. If a lane closure is required to complete installation of the water main, traffic stoppage may be limited to 15 minutes in either direction.

### LIQUIDATED DAMAGES

If said work is not completed within the time stated in the Notice to Proceed, the Contractor shall be liable and hereby agrees to pay to the Owner as liquidated damages, and not as a penalty, the amount of five hundred dollars (\$500.00) per calendar day for each and every part of a day thereafter that said work remains substantially incomplete for a location. The County reserves the right, at its sole discretion, to deduct liquidated damages from any outstanding amount due the Contractor.

### PRE-BID MEETING

No Pre-bid conference will be held. All work will occur in the public right-of-way and the corridor is available for independent access. The Bidder is required to be familiar with the site conditions prior to submitting a bid.

### SCOPE OF WORK

<u>Site Improvements</u>: Contractor shall provide all labor, superintendence, tools, equipment, testing, project safety, and other ancillary items necessary as identified to complete the improvements shown on Construction Plans prepared by the Timmons Group, entitled "Technical Specifications", and dated August 2022.

This project is not subject to stormwater Construction General Permit Coverage (VAR10) but requires a local VSMP Authority permitting for land disturbing and posting of an erosion and sediment control bond.

All Work shall be completed in accordance with the 2018 edition of the Virginia Statewide Building Code. Contractor shall obtain all required permits. County will waive local permit fees.

### WARRANTY

Contractor shall provide a warranty on all work for a period of one (1) year after final completion.

### **PROJECT SCHEDULE**

The County requires all work to be substantially complete within 335 days of notice to proceed. Refer to Bid Form for Contract Time reference. Final completion shall be 30 days after substantial completion.

### PAYMENT TERMS

Terms of payment on work performed with a good and correct invoice shall be Net 30 days with a 5% retainage.

### **PRICING – PAY ITEMS**

Pay Items prices shall include the furnishing of labor, material, testing and all incidental work called for in the Contract Documents. The prices in the tabulation on the Bid Form are to be used only if conditions result in a substantially higher or lower requirement than the estimated quantity. If progressive payments for overages is required there will be a 5% retainage withheld until the final payment for the project is made.

- 9. Governing Document: The solicitation document maintained by Purchasing in the bid file, shall be considered the official copy. In the case of any inconsistency between bid documents submitted to the County, but not clearly listed as an exception, the language of the official copy shall prevail. Furthermore, any exception or change to the specifications made by the bidder may be cause to disqualify your bid.
- 10. **Award**: Award will be made to the lowest responsive and responsible bidder. The quality of the goods and/or services to be supplied, their conformity with the specifications, their suitability to the requirements, the delivery, qualifications and references will be taken into consideration in making the award. The County reserves the right to refuse all bids. Determination of low bid shall be determined by the Total Bid including the deduct for installing 12" C900 PVC instead of 12" class 52 ductile iron pipe.
- Brand Names: The use of the name of a manufacturer, brand, make or catalog designation in specifying an item shall restrict bidders to the manufacturer, brand, make or catalog designation identified, unless qualified by the provision "or equal." If qualified by the provision "or equal" the Brand Names are used simply to indicate the character, quality and/or performance equivalence of the goods and/or services desired. The goods and/or services on which bids are submitted must be of such character, quality and/or performance equivalence that it will serve as that specified. In submitting bids on goods and/or services other than as specified, bidder shall furnish complete data and identification with respect to the alternate goods and/or services that they propose to furnish. It shall be in the County's sole judgment if a substitute product offered is an approved equal and acceptable.

- 12. <u>Samples</u>: Samples, when requested, must be furnished free of expense, and upon request, if not destroyed, will be returned at the bidder's risk and expense. Once a decision to award has been made, samples may be returned. Those left for more than 60 days may incur storage fees or be disposed of by the County.
- 13. Negotiation: Unless canceled or rejected, a responsive bid from the lowest responsible bidder shall be accepted as submitted; except that if the bid from the lowest responsible bidder exceeds available funds, the County may negotiate with the apparent low bidder to obtain a contract price within the available funds.
- 14. <u>Announcements</u>: Upon the award or the announcement of the decision to award a contract, the County will publicly post such notice on the bulletin board located outside of the Purchasing Division and on the County's web site: <a href="http://www.co.isle-of-wight.va.us/budget-and-finance/">http://www.co.isle-of-wight.va.us/budget-and-finance/</a>
- 15. <u>County's Rights</u>: The County reserves the right to reject any and all bids, and to waive any informality if it is determined to be in the best interest of the County.
- 16. **Prices**: Prices shall be stated in units of quantity specified. No additional charges shall be passed to the County, including any applicable taxes, delivery, or surcharges. Prices quoted shall be the final cost to the County. In case of error in the extension of prices, the unit price shall govern.
- 17. **Corrections**: All prices and notations should be in ink or typewritten. Mistakes may be crossed out and corrections made in ink and must be initialed and dated by the person signing the bid.
- 18. **Delivery**: The time of performance of work must be as required in the specifications.
- 19. **Standard equipment**: Any equipment delivered must be standard, new and unused equipment, latest model, except as otherwise specifically stated in the bid. Where any part or the normal accessories of equipment is not described, it shall be understood that all the equipment and accessories that are usually provided in the manufacturer's stock model shall be furnished.
- 20. <u>Silence of Specifications</u>: The apparent silence of these specifications and any supplemental specifications as to any detail or the omission from the specifications of a detailed description concerning any point shall be regarded as meaning that only the best commercial practices are to prevail and correct type, size and design are to be used. All interpretations of these specifications shall be made on the basis of this statement.
- 21. <u>Capacity of Bidder:</u> All bids must be signed by a responsible officer or employee having the authority to bind the firm in contract. The bidder agrees that its contract performance shall be in strict conformance with the contract documents.
- 22. **Rights to Damages**: By signing this bid, the bidder assigns to the County any and all rights that it may have under the antitrust laws of the United States and the Commonwealth of Virginia in any way arising from or pertaining to this bid. This provision is remedial in nature and is to be liberally construed by any court in favor of the County.
- 23. <u>Anti-collusion</u>: The bidder certifies by signing this Invitation for Bid that this bid is made without prior understanding, agreement, or accord with any other person or firm submitting a bid for the

same goods and/or services and that this bid is in all respects bona fide, fair, and not the result of any act of fraud or collusion with another person or firm engaged in the same line of business or commerce. Any false statement hereunder may constitute a felony and can result in a fine and imprisonment, as well as civil damages.

- 24. **Indemnification**: The Contractor shall defend, indemnify and hold the County, and the County's employees, agents, and volunteers, harmless, from and against any and all damage claim, liability, cost, or expense (including, without limitation, attorney's fees and court costs) of every kind and nature (including, without limitation, those arising from any injury or damage to any person, property or business) incurred by or claimed against the contractor, its employees, agents, and volunteers, or incurred by or claimed against the County, the County's employees, agents, and volunteers, arising out of, or in connection with, the performance of all services hereunder by the contractor. This indemnification and hold harmless includes, but is not limited to, any financial or other loss including, but not limited to, any adverse regulatory, agency or administrative sanction or civil penalties, incurred by the County due to the negligent, fraudulent or criminal acts of the contractor or any of the Contractor's officers, shareholders, employees, agents, contractors, subcontractors, or any other person or entity acting on behalf of the Contractor. Unless otherwise provided by law, the Contractor indemnification obligations hereunder shall not be limited in any way by the amount or type of damages, compensation, or benefits payable by or for the Contractor under worker's compensation acts, disability benefit acts, other employee benefit acts, or benefits payable under any insurance policy. This paragraph shall survive the termination of the contract including any renewal or extension thereof. (Isle of Wight has no legal authority to indemnify others. Firms submitting responses agree that they will not require the County to indemnify them in any resulting contract.)
- 25. **Laws. Regulations**: The Contractor shall keep fully informed of all federal, state, and local laws, ordinances and regulations that in any manner affect the conduct of the work. The Contractor shall at all times observe and comply with all such laws, ordinances and regulations.
- 26. Alien employment: The Contractor certifies that he does not and shall not during the performance of the contract for goods and services in the Commonwealth, knowingly employ unauthorized aliens as defined in the federal Immigration Reform and Control Act of 1986, as amended.
- 27. **SCC Authorization**: All bidders or offerors organized or authorized to transact business in the Commonwealth pursuant to Title 13.1 or Title 50, as amended, shall include the identification number issued to it by the State Corporation Commission. Any bidder or offeror that is not required to be authorized to transact business in the Commonwealth as a foreign business entity under Title 13.1 or Title 50, as amended, or as otherwise required by law shall include in its bidor proposal a statement describing why the bidder or offeror is not required to be so authorized.

Any business entity that enters into a contract with a public body pursuant to this chapter shall not allow its existence to lapse or its certificate of authority or registration to transact business in the Commonwealth, if so required under Title 13.1, or Title 50, as amended, to be revoked or cancelled at any time during the term of the contract. The County may void any contract with a business entity if the business entity fails to remain in compliance with the provisions of this section.

28. <u>Contractor's License</u>: If any of the services promulgated under this solicitation consist of construction work, it is required under Title 54.1, Chapter 11, Code of Virginia, for a contractor who performs or manages construction, removal, repair, or improvement when the total value referred to in a single contract or project is:

One hundred twenty thousand dollars (\$120,000) or more, or the total value of all such construction, removal, repair or improvements undertaken by such person within any twelve- month period is seven hundred fifty thousand dollars (\$750,000) or more shall show evidence of being licensed as a Class A Contractor.

Ten thousand dollars (\$10,000) or more, but less than one hundred twenty thousand dollars (\$120,000) or the total value of all such construction, removal, repair, or improvement undertaken by such person within any twelve-month period is one hundred and fifty thousand dollars (\$150,000) or more, but less than seven hundred fifty thousand dollars (\$750,000) shall show evidence of being licensed as a Class B Contractor.

Over one thousand (\$1,000) but less than ten thousand (\$10,000), or the total value of all such construction, removal, repair, or improvements undertaken by such person within any twelvementh period is one hundred and fifty thousand dollars (\$150,000) shall show evidence of being licensed as a Class C Contractor.

29. **Payment Terms**: Payment terms shall be 'Net 30'days, from the date of Contractor invoice approval by the County. Payment terms, if offered, shall not be considered in determining the low bidder. Discount period, if offered, shall be computed from the date of proper receipt of the contractor's correct invoice, or from the date of acceptable receipt of the goods and/or services, whichever is latest. The payment terms stated herein must appear on the contractor's invoice. Failure to comply with this requirement shall result in the invoice being returned to the contractor for correction. Late payment charges shall not exceed the allowable rate specified by the Commonwealth of Virginia Prompt Payment Act. (1% per month)

Contractor shall submit invoices in duplicate, such statement to include detailed breakdown of all charges, and shall be based on completion of tasks or deliverables.

Individual Contractors shall provide their social security numbers, and proprietorships, partnerships, and corporations shall provide their federal employer identification number on their submittal.

- 30. **Default**: In event of default by the Contractor, the County reserves the right to procure the services from other sources and hold the Contractor liable for any excess cost occasioned thereby. Such actions taken by the County shall not release the contractor from additional remedies that may be allowed by law.
- 31. **Availability of Funds**: A contract shall be deemed in force only to the extent of appropriations available to each department for the purchase of such goods and/or services. The County's extended obligations on those contracts that envision extended funding through successive fiscal periods shall be contingent upon actual appropriations for the following years.
- 32. **Appeals Procedure**: Upon your request, administrative appeals information will be provided that shall be used for hearing protests of a decision to award, or an award, appeals from refusal to allow withdrawal of bids, appeals from disqualification, appeals for debarment or suspension, or determination of non-responsibility and appeals from decision or disputes arising during the performance of a contract. To be timely all appeals shall be made within the time periods set forth by the Virginia Public Procurement Act, §2.2-4357, et seq. Contact the buyer at once for assistance.
- 33. **Faith-based Organizations**: The County of Isle of Wight does not discriminate against faith-based organizations.
- Anti-Discrimination: By submitting their bids, bidders certify to the County that they will conform to the provisions of the Federal Civil Rights Act of 1964, as amended, as well as the Virginia Fair Employment Contracting Act of 1975, as amended, where applicable, the Virginians with Disabilities Act, the Americans with Disabilities Act and 2.2-4311 of the Virginia Public Procurement Act (VPPA). If the award is made to a faith-based organization, the organization shall not discriminate against any recipient of goods, services, or disbursements made pursuant to the contract on the basis of the recipient's religion, religious belief, refusal to participate in a religious practice, or on the basis of race, age, color, gender or national origin and shall be subject to the same rules as other organizations that contract with public bodies to account for the use of the funds provided; however, if the faith-based organization segregates public funds into separate accounts, only the accounts and programs funded with public funds shall be subject to audit by the public body. (Code of Virginia 2.2.4343.1E).

In every contract over \$10,000 shall include the following provisions:

- 1. During the performance of this contract, the Contractor agrees as follows:
  - a. The Contractor will not discriminate against any employee or applicant for employment because of race, religion, color, sex, national origin, age, disability, service-disabled veterans, or any other basis prohibited by state law relating to discrimination in employment, except where there is a bona fide occupational qualification reasonably necessary to the normal operation of the Contractor. The Contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices setting forth the provisions of this nondiscrimination clause.
  - b. The Contractor, in all solicitations or advertisements for employees placed by or on behalf of the Contractor, will state that such Contractor is an equal opportunity employer.
  - c. Notices, advertisements and solicitations placed in accordance with federal law, rule or regulation shall be deemed sufficient for the purpose of meeting these requirements.

- 2. The Contractor will include the provisions of Section a, b, and c above in every subcontractor purchase order over \$10,000, so that the provisions will be binding upon each subcontractor or vendor.
- 35. **Drug-Free Workplace**: During the performance of this contract, the Contractor agrees to (1) provide a drug-free workplace for the Contractor's employees; (2) post in conspicuous place, available to employees and applicants for employment, a statement notifying employees that the unlawful manufacture, sale, distribution, dispensation, possession, or use of a controlled substance or marijuana is prohibited in the Contractor's workplace and specifying the actions that will be taken against employees for violations of such prohibition; (3) state in all solicitation or advertisement for employees placed by or on behalf of the Contractor that the Contractor maintains a drug-free workplace; and (4) include the provisions of the foregoing clauses in every subcontract or purchase order of over \$10,000, so that the provisions will be binding upon each subcontractor or vendor.

For the purposes of this section, "drug-free workplace" means a site for the performance of work done in connection with a specific contract awarded to a Contractor, the employees of whom are prohibited from engaging in the unlawful manufacture, sale, distribution, dispensation, possession or use of any controlled substance or marijuana during the performance of the contract.

- 36. **Assignment of Contract**: A contract shall not be assignable by the Contractor in whole or in part without the written consent of the County.
- 37. **Independent Contractor**: The Contractor and any employees, agents, or other persons or entities acting on behalf of the Contractor shall act in an independent capacity and not as officers, employees, or agents of the County.
- 38. Scheduling and Delays: The parties to any contract resultant of this solicitation acknowledge that all or part of the work to be performed hereunder may be delayed and extended at the option of the County. Such delays may be caused by delays, denials and modifications of the various state or federal permits, or for other reasons. The County shall not be required to pay any of the Contractor's direct or indirect costs, or claims for compensation, extended overhead, or other damage or consequential damages arising out of or related to any delays or interruptions required or ordered by the County. If the County delays the project for any reason for a continuous period of ninety (90) days or more, the County and Contractor will negotiate a mutually agreeable adjustment to the Contractor's award amount. Notwithstanding the above, in construction contracts, to the extent that an unreasonable delay is caused by the act or omissions of the County due to causes within the County's control, the above waiver or release shall not apply.
- 39. Governing Law: This Agreement is made, entered into, and shall be performed in the County of Isle of Wight, Virginia, and shall be governed by the applicable laws of the Commonwealth of Virginia without regard to its conflict of law rules. In the event of litigation concerning this Agreement, the parties agree to the exclusive jurisdiction and venue of the Circuit Court of the County of Isle of Wight, Virginia; however, in the event that the federal court has jurisdiction over the matter, then the parties agree to the exclusive jurisdiction and venue of the U.S. District Court for the Eastern District of Virginia, Norfolk Division.

The Contractor shall not cause a delay in services because of the pending or during litigation proceedings, except with the express, written consent of the County or written instruction/order from the Court.

- 40. **Severability**: If any provision of this contract or the application thereof to any person or circumstances shall to any extent be invalid or unenforceable, the remainder of this contract, or the application of such provision to persons or circumstances other than those which it is invalid or unenforceable, shall not be affected hereby, and each provision of this contract shall be valid and enforced to the full extent permitted by law.
- 41. **Termination for Convenience**: The County may at any time, and for any reason, terminate this Contract by written notice to Contractor specifying the termination date, which shall be not less than thirty (30) days from the date such notice is mailed.

Notice shall be given to Contractor by certified mail/return receipt requested at the address set forth in Contractor's Bid Proposal or as provided in this Contract. In the event of such termination, Contractor shall be paid such amount as shall compensate Contractor for the work satisfactorily completed, and accepted by the County, at the time of termination. If the County terminates this Contract, Contractor shall withdraw its personnel and equipment, cease performance of any further work under this Contract, and turn over to the County any work completed or in process for which payment has been made.

42. **Termination for Cause**: In the event that Contractor shall for any reason or through any cause be in default of the terms of this Contract, the County may give Contractor written notice of such default by certified mail/return receipt requested at the address set forth in Contractor's Bid/Proposal or as provided in this Contract.

Unless otherwise provided, Contractor shall have ten (10) days from the date such notice is delivered, whether electronic, by mail, or in person, in which to cure the default. Upon failure of Contractor to cure the default, the County may immediately cancel and terminate this Contract as of the delivery date, whether electronic, US Mail, or by hand, of the default notice.

Upon termination, Contractor shall withdraw its personnel and equipment, cease performance of any further work under the Contract, and turn over to the County any work in process for which payment has been made. In the event of violations of law, safety or health standards and regulations, this Contract may be immediately cancelled and terminated by the County and provisions herein with respect to opportunity to cure default shall not be applicable.

43. <u>Contact Prohibition</u>: Direct contact with County departments other than Purchasing, on the subject of this bid, is expressly forbidden except with the foreknowledge and permission of the Contract Officer. Violation may result in a determination that your firm is ineligible for an award.

All questions shall be in writing to the Contract Officer shown on the title page of the bid. The respondents to this IFB shall not contact, either directly or indirectly, any other employee or agent of the County regarding this IFB. This prohibition shall also extend to the County Board of Supervisors and locally elected officials. Any such unauthorized contact may disqualify the bidder from this procurement.

44. Additional Conditions: The Conditions and Instructions in this solicitation are intended to apply to the resulting contract and shall supersede any conflicting terms offered. Any additional conditions a bidder intends be considered must be submitted with the bid and noted as an exception. Such exceptions may result in a finding that the submittal is 'non-responsive' to the bid, negating possibility of an award to that bidder. Contractual documents submitted by the successful firm after an award will not be accepted.

- 45. **Contractor Failure to Perform**: Failure of the Contractor to perform the contract by reason of the County's non-acceptance of additional conditions submitted after the award shall result in termination of the contract by the County and may result in debarment of the Contractor for a period of up to three (3) years. Termination and /or debarment of the Contractor shall not constitute a waiver by the County of any other rights or remedies available to the County by law or contract.
- 46. <u>Conflict</u>: In the event of a conflict between the contract documents, including these Conditions and Instructions, and the terms of a purchase order, or related document issued by Purchasing, the contract documents shall control.
- 47. **Records and Inspection**: The Contractor shall maintain full and accurate records with respect to all matters covered under this contract, including, without limitation, accounting records, written policies, procedures, time records, telephone records, and any other supporting evidence used to memorialize, reflect, and substantiate charges or fees related to this contract. The Contractor's records shall be open to inspection and subject to audit and/or reproduction, during normal working hours, by the County and its employees, agents or authorized representatives after giving at least three (3) days' notice to the Contractor by the County. The County shall have access to such records from the effective date of this contract, for the duration of the contract, and for five (5) years after the date of final payment by the County to the Contractor pursuant to this contract or any renewal or extension of this contract. The County's employees, agents or authorized representatives shall have access to the Contractor's facilities, shall have access to all necessary records and shall be provided adequate and appropriate workspace, in order to conduct audits.
- 48. **Rights and Remedies Not Waived**: In no event shall the making by the County of any payment to the Contractor, or the waiver by the County of any provision under this contract including any obligation of the Contractor, constitute or be construed as a waiver by the County of any other provision, obligation, breach of covenant, or any default which may exist under this contract on the part of the Contractor, and the making of any such payment by the County while any such breach or default exists shall not impair or prejudice any right or remedies available to the County.
- 49. **Entire Agreement**: This contract and any additional or supplementary documents incorporated herein by reference contain all the terms and conditions agreed upon by the parties hereto, and no other agreements, oral or otherwise, regarding the subject matter of this contract or any part thereof shall have any validity or bind any of the parties hereto. This contract shall not be modified, altered, changed or amended unless in writing and signed by the parties hereto.
- 50. <u>Conflicts of Interests</u>: Contractor shall not accept or receive commissions or other payments from third parties for soliciting, negotiating, procuring, or effecting insurance on behalf of the County.
- S1. Responsibility of Contractor: The Contractor shall, without additional costs or fee to the County, correct or revise any errors or deficiencies in his performance. Neither the County's review, approval or acceptance of, nor payment for any of the services required under this Agreement shall be deemed a waiver of rights by the County, and the Contractor shall remain liable to the County for all costs which are incurred by the County as a result of the Contractor's negligent performance of any of the services furnished under this Agreement.
- 52. **Changes and Additions**: It shall be the responsibility of the Contractor to notify the County, in writing, of any necessary modifications or additions in the Scope of this Agreement. Compensation for changes or additions in the Scope of this Agreement will be negotiated and approved by the County, in writing.

It is understood and agreed to by both the County and the Contractor that such modifications or

additions to this Agreement shall be made only by the full execution of the County's standard Agreement change order form. Furthermore, it is understood and agreed by both parties that any work done by the Contractor on such modification or addition to this Agreement prior to the County's execution of its standard Agreement change order form shall be at the total risk of the Contractor and said work may not be compensated by the County.

- 53. **Debarment Status**: By submitting a bid, bidders certify that they are not currently debarred by the Commonwealth of Virginia from submitting bids or proposals on contracts for the type of goods and/or services covered by this solicitation, nor are they an agent of any person or entity that is currently so debarred.
- 54. <u>Safety</u>: All Contractors and subcontractors performing services for the County are required and shall comply with all Occupational Safety and Health Administration (OSHA), State and County Safety and Occupational Health Standards and any other applicable rules and regulations. Also, all Contractors and subcontractors shall be held responsible for the safety of their employees and any unsafe acts or conditions that may cause injury or damage to any persons or property within and around the work site area under this contract.
- 55. <u>License Requirement</u>: All firms doing business in the County of Isle of Wight are required to be licensed in accordance with the County of Isle of Wight business license ordinance. Wholesale and retail merchants without a business location in the County of Isle of Wight are exempt from this requirement. Any questions concerning business licenses should be directed to the Commissioner of the Revenue's Office.
- 56. Contractor's Form: In cases where the County may accept the Contractor's form agreement, whereas certain standard clauses that may appear in the Contractor's form agreement cannot be accepted by the County, and in consideration of the convenience of using that form, and this form, without the necessity of negotiating a separate contract document, the parties hereto specifically agree that, notwithstanding any provisions appearing in the attached Contractor's form contract, the County's contract addendum shall prevail over the terms of the Contractor's agreement in the event of a conflict.
- 57. <u>Contract Quantities</u>: The quantities specified in the Invitation for Bid are estimates only unless otherwise clearly noted and are given for the information of bidders and for the purpose of bid evaluation. They may not indicate the actual quantity that will be required, since such volume will depend upon requirements that may develop during the contract period. Quantities shown shall not be construed to represent any amount which the County shall be obligated to purchase under the contract or relieve the Contractor of his obligation to fill all orders placed by the County, except as clearly noted. To make determination of low bid these quantities shall be used.
- 58. **Bidder Oualifications**: Only bids from established contractors for work similar in scope to work herein shall be considered; the County reserves the right to request specific reference information prior to award. Bidder shall demonstrate that he has adequate and appropriate manpower, tools and equipment to respond and perform in accordance with the provisions herein.

The County may, at its option, disqualify a bidder and reject his bid for cause. Reasons deemed to be sufficient for this action shall include, but not be limited to, the following:

- o Evidence of collusion among bidders.
- Receipt of more than one bid on any project from an individual, or from a corporation.
   This restriction does not apply to subcontractors

- o Default on any previous contract.
- o For unreasonable failure to complete a previous contract within the specified time or for being in arrears on an existing contract without reasonable cause for being in arrears.
- o Inability to perform as revealed by an investigation of the Bidder's financial statement, experience and/or plant and equipment.
- Contractor does not meet project-specific requirements, as identified in the Contract Documents.
- 59. <u>Competition Intended</u>: It is the County's intent that the Invitation for Bid (IFB) permits competition. It shall be the bidder's responsibility to advise the Buyer in writing if any language requirement, specification, etc., or any combination thereof, inadvertently restricts or limits the requirements stated in this IFB to a single source. Such notification must be received by the Contract Officer prior to the date set for bids to close.
- 60. **Value Engineering**: The purchasing agent may provide for incentive contracting that offers a Contractor whose bid is accepted, the opportunity to share in any cost savings realized by the locality when the projects costs are reduced by such Contractor, without affecting project quality, during the construction of the project. The fee, if any, charged by the project engineer or architect for determining such cost savings shall be paid as a separate cost and shall not be calculated as part of any cost savings. Such provisions, including the percentage of cost sharing, shall be included in the language of the contract or may be added by change order with the agreement of both parties.
- 61. **Default on Taxes**: The County reserves the right to withhold payment to any contractor that is in arrears, or in default to the County on any debt or Contract, or that has defaulted as a surety, or otherwise on any obligation to the County.
- 62. **Faster Payments**: The County prefers to make payment with the County's Purchasing Card, or by direct deposit (EFT). If you are willing to use either of these methods for faster turnaround of payments to your firm, please register at one, or both of the following sites:

### **INSURANCE REQUIREMENTS**

The Contractor shall comply with the insurance requirements set forth in the Contract, including the items set forth below:

- A. Neither the Contractor nor any subcontractor shall commence work under this Contract until the Contractor has obtained and provided proof of the required insurance coverages to the County, and such proof has been approved by the County. The Contractor confirms to the County that all subcontractors have provided Contractor with proof of such insurance or will do so prior to commencing any work under this Contract.
- B. Contractor, including all subcontractors, shall, at their sole expense, obtain and maintain during the life of this Contract the insurance policies and/or coverages required by this section. The County and its officers, employees, agents, assigns, and volunteers shall be added as an additional insured to the general liability and automobile coverages of any such policies and such insurance coverages shall be primary and noncontributory to any insurance and/or self-insurance such additional insureds may have. The Contractor shall immediately notify in writing the County of any changes, modifications, and/or termination of any insurance coverages and/or policies required by this Contract. The Contractor shall provide to the County with the signed Contract an Acord certificate of insurance which states in the description of operations section one of the two paragraphs below:
  - (1) The County and its officers, employees, agents, assigns, and volunteers are additional insureds as coverage under this policy includes ISO endorsement CG20 33 which provides that the insured status of such entities is automatic if required by a contract or a written agreement. If additional insured status is automatic under a different coverage form, Contractor must attach a copy of the coverage form to its certificate. Any required insurance policies shall be effective prior to the beginning of any work or other performance by Contractor and any subcontractors under this Contract.

\$500,000.00 Bodily Injury by Disease Policy Limit.

\$100,000.00 Bodily Injury by Disease each employee.

- (4) Errors and Omissions coverage in an amount of not less than \$1,000,000 per occurrence and in the aggregate. Coverage may be written on an occurrence or claims made coverage form. However, if a claim made coverage form issued, coverage must remain in effect for a minimum of 3 years after the Contractor's work is concluded.
- (5) The required limits of insurance for this Contract may be achieved by combining underlying primary coverage with an umbrella liability coverage to apply in excess of the general and automobile liability policies, provided that such umbrella liability policy follows the form of the underlying primary coverage.

Furthermore, there is no requirement or obligation for the County to seek any recovery against the Contractor's insurance company before seeking recovery directly from the Contractor.



## APPENDIX E

Measurement and Payment

### **Item 1: Mobilization**

Payment for this item shall include mobilization and demobilization necessary to complete the work in the Contract documents.

#### **Item 2: Erosion Control**

Payment for this item shall include all labor, equipment, and material necessary to establish and maintain all sediment and erosion control measures as shown on the plans and in accordance with the SWPPP to be obtained by the Contractor. No additional payment shall be made to reestablish sediment and erosion control measures after heavy rains or for efforts required to remove sediment which may have migrated off the project site.

### Item 3: 8" PVC Water Main

Payment for this item shall include all labor, equipment, and material necessary to install the water main to the lines and grades shown on the contract drawings including bends, fittings, backfilling, compacting, bedding (as detailed in the Contract Document), dewatering, disinfection, disposal of surplus material, excavation, heat fusion equipment and any specialized technical operational support required, restoration in right-of-way and easements (not including curb and gutter restoration or pavement restoration, unless otherwise noted), sampling and flushing, shoulder restoration, temporary seeding and stabilization, temporary sheeting and bracing, testing, thrust restraint, tracer wire and marking tape, and water main and appurtenances (including fittings).

### Item 4: 8" HDPE Water Main

Payment for this item shall include all labor, equipment, and material necessary to directional drill the water main as shown on the contract drawings including drill rig, pull pipe, and tracer wire. Two horizonal directional drills are included, one located between Station 12+24.11 and Station 17+24.11, the other one located between Station 49+24.11 and Station 55+74.27. Contractor shall log x, y, z coordinates at every drill down hole, and log pull force during pull back at the end of every pull before placing the pipe in. Diffusion data shall be logged at every joint.

### Item 5: 12" Ductile Iron Water Main

Payment for this item shall include all labor, equipment, and material necessary to install the water main to the lines and grades shown on the contract drawings including bends, fittings, restrained joint pipe, appurtenances, flushing, dewatering, pressure testing, disinfection, bedding as shown on trench detail, removal and disposal of excess material, and successful completion of bacteriological testing. Also included in the linear foot of pipe is excavation, backfill with excavated material, compaction, and installation of tracer wire.

### **Item 6: Pipe Bedding**

Payment for this item shall include all labor, equipment, and material necessary to install VDOT # 57 stone as additional undercut. Pay Item 3 includes the installation of 6" of VDOT #57 stone under the invert of the pipe and up to the top of the pipe. This item is only to be used when additional #57 stone is directed to be installed by the Owner's representative.

### Item 7: Select Fill

Payment for select fill shall include all labor, materials, and equipment to provide select fill per ton as directed by the Owner. Select fill used on the project which has not been authorized by the Owner will not be measured or paid for. Work shall include excavation, removal, and proper disposal of excess material, backfill, and compaction all in accordance with the trench details shown on the contract documents.

#### **Item 8: Air Release Valve**

Payment for this item shall include all labor, equipment, and material necessary to install air release valves as shown on the contract drawings including tapping saddle, corporation stop, continuous brass riser pipe, valve box and 3/4" corporation stop inside valve box.

### **Item 9: Water Main Vault**

Payment for this item shall include all labor, equipment, and material necessary to provide a complete water meter vault near the corporate limits of the Town of Smithfield, as shown in the plans. This item shall include the meter vault, access manholes, piping, valves, meters and bedding as shown on the contract documents.

### **Item 10: Fire Hydrant Assemblies**

Payment for this item shall include all labor, equipment, and material necessary to install fire hydrants as shown on the contract drawings including all appurtenances required for satisfactory operation, backfill, compacting, bedding material, blocking (where required), burlap bag, disposal of surplus material, dewatering, excavation, extension spools, right-of-way restoration, shoulder restoration, stone, temporary seeding and stabilization, temporary sheeting and bracing, testing, thrust restraint, and fire hydrant assembly. Fire hydrant assembly includes valve, valve box, valve box frame and cover, pipe, and fittings as indicated on the Standard Details.

### **Item 11: Connection to Water Mains**

Payment for this item shall include all labor, equipment, and material necessary to connect the water mains as shown on the contract drawings. Water main connections will be performed at Station 10+00.00 on the 8" C900 PVC pipe at the Hardy Elementary School site and at Station 80+52.86 on the 12" Ductile Iron pipe in the Smithfield Food Parking Lot.

### Item 12: 16" Casing Pipe

Payment for this item shall include all labor, equipment, and material necessary to install the casing pipe as shown on the contract drawings. The casing pipe will be installed from the Isle of Wight County School property across Old Stage Road (Route 10) to the intersection with Jenkins Lane. The 16" casing pipe is located between Station 10+02.32 and Station 10+88.32.

### Item 13: 24" Casing Pipe

Payment for this item shall include all labor, equipment, and material necessary to install the casing pipe as shown on the contract drawings. The casing pipe will be installed from the Smithfield Food Parking Lot across North Church Street (Route 10) to the Smithfield Fresh Meats Corp. The 24" casing pipe is located between Station 69+80.17 and Station 71+46.81.

### Item 14: 8" Kennedy Gate Valves

Payment for this item shall include all labor, equipment, and material necessary to install 8" isolation valves along the length of the water main as shown on the plans along the pipe which will be installed in Isle of Wight County.

### Item 15: 12" AVK Stainless Steel Gate Valves

Payment for this item shall include all labor, equipment, and material necessary to install 12" AVK stainless steel isolation valves on all 12" water main installed on Phase 2 of this project in the parking lot of Smithfield Foods up to the meter vault located near the corporate limit of the Town of Smithfield.
